### DEPT OF TRAINING & TECHNICAL EDUCATION: WORKSHOP ON APPRENTICESHIP TRAINING SCHEME, DELHI SECRETARIAT

A workshop on Apprenticeship Training Program was held at Delhi Secretariat Auditorium on 03 Feb 2016. The CEO, Maj Gen A K Sakhuja attended the same. Deputy Chief Minister Delhi Sh. Manish Sisodia inaugurated the re-launch of Apprenticeship Training and employment in Delhi. The workshop was attended by Mr Jayant Krishna, CEO NSDC, Manoj Kumar, Dir TTE, Ms. Priya C Srivastava, Secretary TTE besides the industry heads including Mr. Anil Khaitan, Vice President PHD Chamber of Commerce.

### VISIT FRONTLINE TRAINING CENTRE ON 03 FEB 2016

Col Sunil visited Frontline Training Centre located at A6, Paschim Vihar, Shri Mahaveer Vishwa Vidyapeeth School, New Delhi at 10a.m on 03 Feb 2016. A batch of 54 candidates was to be assessed, but only 19 candidates were present, balance candidates were yet to arrive. Ramesh was the trainer. Mr. Rajinder Singh was assessor who had not reached the site till 10.30a.m.

### MEETING AT DIRECTORATE OF INDIAN ARMY VETERANS (DIAV)

- There are a total of 13 RTCs who are in the fray for running Security Courses for their retiring manpower.
- SSSDC amongst other SSCs is required to visit the Centres to assess the infrastructure and job roles to be run there.
- NSDC and DIAV will be circulating the list of Centres to be visited with dates for planning the visits, senior reps of the SSCs are required to visit these Centres and discuss the requirements of infra and job roles with the Commandant of the Centres.
- A suggestion for restricting the number of visits by SSSDC was given by the undersigned to the DIAV and NSDC which was accepted and the visits being planned now for SSSDC are for RTCs in four directional zones namely East, West, North, and South.
- Requirement of Curriculum and content mapping for the job roles planned would be required to be done for running of the courses post the visits.
- Training of Army Trainers would also need to be done for making the Centres self-sufficient for trained staff to run the courses in the future, planning of TOT courses would thus need to be done.

### REGIONAL DIRECTORS MEET 15 FEB16

Regional Directors Meet was held on 15 Feb 2016. Chairman welcomed all Regional Directors and thereafter CEO, COO and all officers of SSSDC briefed the Regional Directors regarding their respective roles and issues related to Regional Directors.

### CONDUCT OF RPL

The meeting as convened was attended on 17 Feb 2016 between 1800h to 2030h by CEO and Principal T&D. It was chaired by the JS MSDE Mr Rajesh Aggarwal. The following proposals were discussed pending finalisation:

- Process to maximise the uploading in RPL to include ABs acting as TPs to mobilise and conduct assessments in the organised sector. This would reduce one stakeholder in the process and bring in speed. This would be left open to SSCs to adopt if found suitable in their sectors.

- Proposal to bifurcate the reward money pay outs between the Trainee and the TP to make it more attractive to the TPs.

### WORKSHOP WITH DGR MINISTRY OF DEFENSE

A workshop with DGR ministry of Defense was chaired by Ms. Damyanti, JS, Veterans Welfare on 17 Feb 2016 at DGR, RK Puram, New Delhi was attended by the CEO, SSSDC. Workshop was also attended by Security Training Partners of DGR. Decision taken to align all DGR Security courses to existing Ops/ NOS.

### VISIT TO BHUBANESHWAR (ODISHA) ON 18 FEB 2016

CEO, SSSDC visited Bhubaneswar as part of NSDC delegation on 18 Feb 2016. The visit was organized by NSDC, Mr Mohan Reddy in two phases. Phase 1 on 18 Feb 2016, where in 14 SSCs participated and Phase 2 on 19 Feb 2016 where in the balance of SSCs took part.

The aim of the visit was to review the Skill Development initiatives under taken at Centurion University and IL&FS Institute of Skill Development, Bhubaneswar.

The delegation of 14 SSC CEOs was received at the Airport and transported by bus to Centurion University Campus (approx. 40KM away). The round of the Skill Development Workshops revealed a highly well-organized training curriculum being executed, mainly under DDUGKY Scheme. Security Sector Skill is nonexistent in Centurion but the Head, Prof. Mishra is keen to carryout Assessment as an assessment body of Security Sector. In subsequent times they would like to apply to set up Training Centre as TP.

**IL&FS** The visit was conducted at 3PM. A total of 14 Skills are being developed, which once again does not include Security as a discipline. There is no future plan to establish the Security Skill Development at Bhubaneswar Training Centre
