Important issues with respect to PMKVY were explained to the ABs by Master Trainer. Some important issues were highlighted by the Chairman & the CEO. These included the forming of Vigilance Cells by ABs to ensure PMKVY assessments are undertaken with due diligence and integrity. Other important issues discussed during the meeting are Progress in making Assessment Tools, NSQF Level wise, Integrity Issues, fraud detection mechanism for both trainees and assessors, Feedback mechanism, System of surprise checks, System for maintaining data for 10 years & Procedure undertaking before/after any assessment (briefing, de-briefing etc.)

MEETING: CII RECONSTITUTED NATIONAL COMMITTEE ON SSSDC 2015-16.

On 10 Jun 2015, the CEO attended the first meeting of "CII Reconstituted National Committee on SSCs" in India Habitat Centre, Lodhi Road, New Delhi. The meeting was attended by all CEOs of Skill Councils, MD/CEO of NSDC, two Joint Secretaries from MSDE and FICI rep, amongst them. A number of issue were discussed during the meeting; the salient ones are as under:-
